Organization Structure:

The town-sanctioned Millbrook Meadow and Mill Pond Committee and Rockport Millbrook Meadow Conservancy work hand-in-hand to raise awareness, execute the restoration efforts and plan for long-term stewardship of the meadow and its waterways. These committees are all-volunteer community organizations. The Millbrook Meadow Conservancy is a component fund of the Essex County Community Foundation and is the active fundraising arm of the restoration effort. In addition to the Conservancy Board, an Advisory Committee consisting of individuals from various fields of expertise directly support the Conservancy Board's efforts.
